## Fundamentals for Joint Occupational Health & Safety Committees

**Objective:** To offer an eight hour Joint Health and Safety Committee member training course that complies with WorkSafeBC's recently enacted mandatory training requirements for new joint health and safety committee members.

**Target Groups:** New Joint Health & Safety Committee members or experienced Members who could benefit from refresher training.

**Learning Outcomes:**

1. Know how to use the OH&S Regulation, Workers Compensation Act and OHS Guidelines to determine the regulatory requirements for their Safety Committee and workplace
2. Summarize the duties, functions, and roles for Safety Committees and its co-chairs.
3. Understand and explain the purpose of a safety committee's *Terms of Reference* and how to apply its policies and procedures.
4. Explain the role of the Joint Health & Safety Committee in:
  - Assisting in having all required OH&S program elements in place
  - Safety inspections
  - Accident investigations
  - Right to Refuse Unsafe Work
  - Working cooperatively to address workers' health and safety concerns.
4. Summarize Safety Committee Members educational requirements, including conducting individual needs assessments for the purposes of selecting training.
5. Explain the prohibition against discriminatory action
6. Identify when an employer is required to consult with the committee
7. Understand and explain the purpose of conducting the annual evaluation of the Joint Safety Committee's effectiveness.

**Format:** Lectures, and Group Discussion

**Length:** 8 hours

**Materials:** Tables and chairs for all involved. Whiteboard or flipchart. LCD computer projector (we can provide a projector with prior notice). Pencils or pens for all involved.
